An Bord Pleanála has, on the 12th day of May 2025, made a confirmation order confirming with modifications the above-named compulsory purchase order as respects the land and/or rights described in Part I, Part II and Part IV (Section A) of the Schedule hereto. While a notice of the confirmation of the said order was published on 12th June 2025 in the Dublin Gazette, it has come to the National Transport Authority’s attention that due to the administrative errors a small number of plots were omitted from the schedule to that notice and therefore the National Transport Authority is publishing this corrected notice.

The said order, as so confirmed as modified authorises the National Transport Authority to acquire the said land and/or rights compulsorily. It will become operative three weeks from the date of publication of this notice.
